

**MINUTES OF THE ANNUAL GENERAL MEETING OF OKEFORD FITZPAINE PARISH COUNCIL HELD AT THE PAVILION, CASTLE LANE ON TUESDAY, 3<sup>rd</sup> May 2022 at 7.30pm.**
